WHAT IS THIS PRODUCT?

Type

The Fund is a mutual fund under the UCITS Directive that invests its assets mainly in fixed income fund, collective investment scheme and alternative investment fund units (including ETF units) globally in fixed income and equity markets.

Investment term

The fund has no maturity date. The recommended holding period is at least 5 years. In principle, fund units may be subscribed for and redeemed on every Finnish banking day. The Management Company may, at its discretion, decide to dissolve or merge the Fund or its unit series. The Management Company has the right to redeem a unit-holder's units on its own initiative in the exceptional circumstances described in the Fund's rules.

Objectives

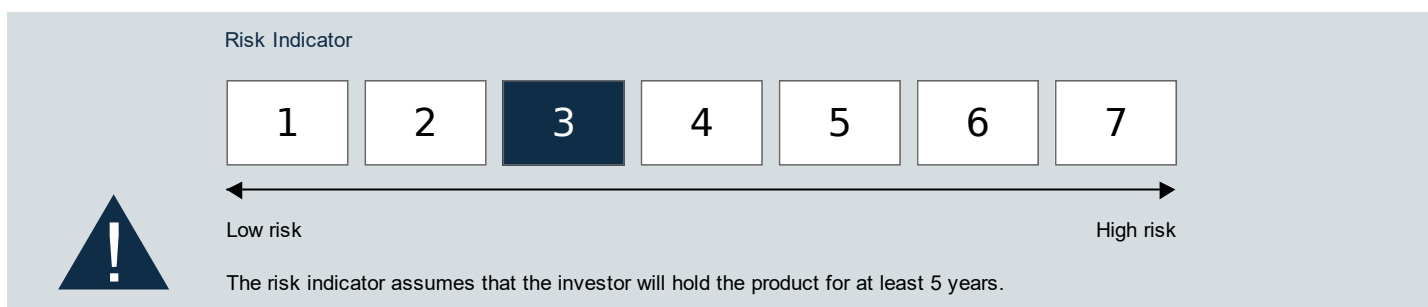
- The Fund's objective is to provide its unit holders with a return that exceeds the return of the benchmark index over the long term.
- In addition to investments in units of mutual funds, collective investment schemes and alternative investment funds, the Fund's assets may also invest directly in equities and equity-linked instruments, bonds issued by corporations, governments and other entities, money market instruments and deposits with credit institutions, in accordance with the rules of the Fund. There are no restrictions on the minimum or maximum credit rating of the underlying companies associated with the Fund's fixed income investments. There are no restrictions on the geographical diversification of the Fund. In its investment activities, the Fund may use standardized and non-standardized derivative contracts to hedge investments and seek returns as part of its investment strategy.
- The Fund's return benchmark index consists of the following: 5.0% OMX Helsinki Cap GI (HEXYP), 14.0% MSCI Daily Europe TR NET Index EUR (MSDEE15N), 14.0% MSCI North America TR NET EUR (MSDENAN), 4.0% MSCI Daily Net TR Japan Euro (MSDEJNN), 8.0% MSCI Daily TR Net Emerging Markets EUR (MSDEEEMN), 5.0% MSCI AC Daily World TR Net Index (EUR) (NDEEWNR), 15.0% JP Morgan GBI EMU Government Bond LC (JPMGEMLC), 15.0% ICE BofAML EMU Corporate EUR (ER00), 10.0% ICE BofAML European Ccy Dev Markets High Yield Constr (HPCD), 5.0% JP Morgan EMBI Global Diversified Hedged EUR (JPGCHECP), and 5.0% ICE BofAML Euro Ccy LIBORN 3M const.mat. (LEC3). The Fund is actively managed. The Fund's performance may deviate from the performance of the benchmark index due to active portfolio management. The Fund's base currency is the euro. The Fund's unit series A is a so-called yield unit, which is paid a return determined annually by the Annual General Meeting of the Management Company..

Intended retail investor

The Fund is suitable for private investors who want to invest in a diversified manner in the equities and fixed income markets. The investor must have a sufficient understanding of the Fund's investments and be prepared to bear the financial risk associated with the investment. The Fund is not suitable as a short-term investment instrument, and the investment horizon should be at least 5 years.

WHAT ARE THE RISKS AND WHAT COULD I GET IN RETURN?



The overall risk indicator expresses the level of risk of this product compared to other products. It indicates how likely the product is to lose money because of market events or because the product developer is unable to pay the investor. On a scale from 1 to 7, the risk category of the product is defined as 3, which is a medium-low risk class. Potential future losses are rated at medium-low, and poor market conditions unlikely to affect the ability of the management company to pay the investor. Risks that may not be fully captured by the risk indicator are 1) currency risk, 2) derivatives risk, 4) operational risk and 5) geographical risk. Be aware of currency risk. The currency of this unit series may be different from that of your country. As the investor may receive payments in the currency of this unit series and not that of the investor's country, the final return will depend on the exchange rate between these two currencies. Performance Scenarios

WHAT ARE THE COSTS?

Costs over Time

The tables show the sums used from the investment to cover diverse types of costs. These sums depend on the amount of the investment and how long the product is held. The amounts shown here are illustrations based on an example investment amount and different investment periods. The assumption is that

- In the first year you would get back the amount invested (0 % annual return). For the other holding periods the assumption is that the product performs as shown in the moderate scenario.

The recommended holding period is based on the fund's risk-reward profile. Fund units may be redeemed on every Finnish banking day excluding those banking days on which the net asset value of the Fund or its investments cannot be determined due to foreign public or bank holidays or if the Management Company has temporarily suspended the calculation of the value of the fund units due to exceptional conditions described in the Fund rules. A list of days on which the trading of fund units is not possible is available from the Management Company and on the Management Company's website.
