This document provides key investor information on the investment product. It is not marketing material. This information is required by law to help you understand the nature, risks, costs, potential gains and losses of this product and to help you compare it with other products.

This PRIIP product has been approved in Finland. The Fund Management Company is authorized in Finland and regulated by the Finnish Financial Supervisory Authority.

WHAT IS THIS PRODUCT?

Type

The Fund is a mutual fund compliant with the UCITS Directive and invests mainly in bonds issued by Nordic companies, financial institutions and other organizations. The Fund's investment strategy will last for a fixed period and end on December 31, 2023 at the latest, by which time the mutual fund will either terminate its operations, merge into another fund or change its rules to specify a new investment strategy.

Investment term

The recommended holding period is until 31.12.2023, when the fund's fixed-period investment strategy ends. Fund units may be subscribed for and redeemed on every Finnish banking day excluding those banking days on which the net asset value of the Fund or its investments cannot be determined due to foreign public or bank holidays or if the Management Company has temporarily suspended the calculation of the value of the fund units due to exceptional conditions described in the Fund rules. A list of days on which the trading of fund units is not possible is available from the Management Company and on the Management Company's website.

Objectives

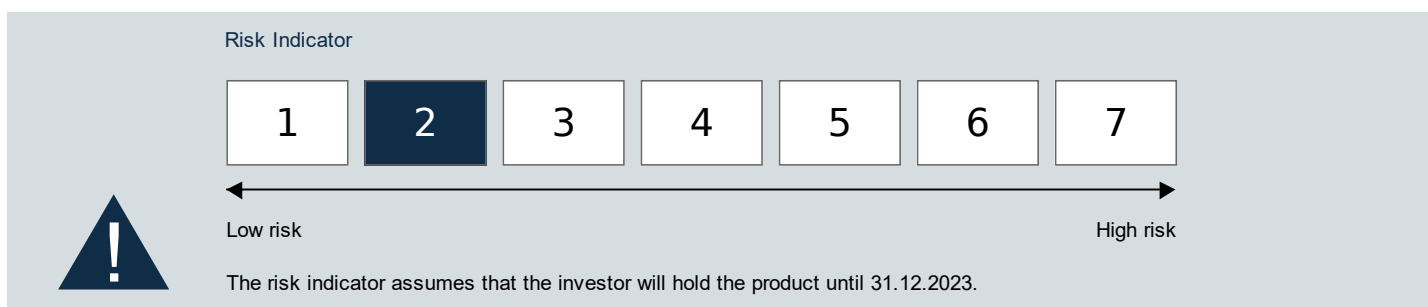
- The Fund targets an annual return of approximately 3%. The Fund does not have an official benchmark index. In addition to other characteristics, the fund promotes environmental and social characteristics and requires that target companies observe good governance.
- The investments will be made in rated Investment Grade and High Yield bonds and unrated corporate bonds. The credit risk arising from individual issuers is reduced by diversifying the investments among various issuers. The fund does not require its investments to be credit rated, which means that the fund's investments are subject to an average or high credit risk. The average repayment term (duration) of the fund's fixed income investments is a maximum of 5 years at the start of the Fund's operations. The Fund will not invest in instruments with a final maturity that would occur after 2024. Variations in the pricing of the credit risk or general interest rate level affect the fund's performance much more than is the case with money market funds. The fund may also invest its assets in derivatives contracts, both for hedging purposes and within the fund's investment strategy. In general, the Fund's investments are passive holdings.
- The fund's base currency is the euro. The returns on the fund's investments will be reinvested.

Intended retail investor

The Fund suits private investors i) who want to benefit from the competitive performance of the Nordic corporate bond market, ii) who prefer a stable Nordic political and economic operating environment, iii) who want to benefit from the fund's easy and effective buy-and-hold strategy, iv) who prefer the fund's active approach to responsible investment, v) who are prepared to commit to the fund until December 31, 2023, when the fund's fixed-period investment strategy will end, and vi) who want to invest responsibly and take into account not only economic analysis but also environmental, social and good governance (ESG) factors. Investors must have a sufficient understanding of the fund's investments and be prepared to bear the potential financial risk associated with the investment.

WHAT ARE THE RISKS AND WHAT COULD I GET IN RETURN?



The overall risk indicator expresses the level of risk of this product compared to other products. It indicates how likely the product is to lose money because of market events or because the product developer is unable to pay the investor. On a scale from 1 to 7, the risk category of the product is defined as 2, which is low risk class. Potential future losses are rated at low, and poor market conditions very unlikely to affect the ability of the management company to pay the investor. The risks that the risk indicator may not necessarily fully take into account are i) liquidity risk, that is, the risk that the Fund's investment instrument cannot be sold or bought in the planned time or at the desired price, ii) credit risk, that is, the uncertainty regarding the bond issuer's ability to repay, and iii) derivatives risk, that is, the use of derivatives to obtain additional returns may increase the fund's risk and return expectation. The use of derivatives for hedging purposes or for risk management may reduce risk and return expectation. The use of derivatives may increase counterparty risk and operational risk.

Be aware of currency risk. The currency of this unit series may be different from that of your country. As the investor may receive payments in the currency of this unit series and not that of the investor's country, the final return will depend on the exchange rate between these two currencies. This risk is not considered in the indicator shown above.

Performance Scenarios

Costs over Time

The tables show the sums used from the investment to cover diverse types of costs. These sums depend on the amount of the investment and how long the product is held. The amounts shown here are illustrations based on an example investment amount and different investment periods. The assumption is that

- In the first year you would get back the amount invested (0 % annual return). For the other holding periods the assumption is that the product performs as shown in the moderate scenario.
